# District Township Supervisors Business Meeting June 17, 2021

#### **BUSINESS MEETING CALL TO ORDER**

Chairman Ed Overberger called to order the District Township Board of Supervisors Business Meeting, held at 202 Weil Road, Boyertown, PA at 7:06 p.m. Present were Chairman Ed Overberger, Vice-Chairman Leonard Robb, Supervisor John Burger, Solicitor Gene Orlando, Engineer John Weber, Emergency Management Coordinator Tim Adam and Secretary Elaine Schwien. #### **MINUTES**

## **SOLICITOR - Eugene Orlando**

**Rubbish and Waste Storage Ordinance:** Discussion was held including various definitions and referencing the existing burning ordinance. Mr. Overberger made a motion authorizing Solicitor Orlando to make the language corrections as discussed and advertise the ordinance for adoption at the July 15, 2021 Board of Supervisors meeting. Seconded by Mr. Robb. All in favor.

# **ROADMASTER - Ed Overberger**

**Stormwater Culverts:** Mr. Weber reported that clearance has been given (re bog turtle) from Fish & Wildlife to DEP for Dogwood Drive. The Merkle Road permit has been received. Mr. Weber would like to advertise and award for next month's meeting. There is a concern about lead time for materials. Mr. Overberger discussed using American Rescue Plan funds as stormwater is an allowable use. Mr. Overberger made a motion to put the Merkle Road and Dogwood Drive Culvert Project out for bid. Seconded by Mr. Robb. All in favor.

**Mower Damage:** Mr. Overberger reported an incident with the Road Crew mowing the roads. The mower hit the edge of a barn on Dogwood Drive knocking some stone out from the corner of the foundation. A proposal for repair was received from Uhler Construction in the amount of \$1,200. Mr. Overberger made a motion to accept the proposal from Seth Uhler Construction, dated 6/16/21, to repair the stone wall, for a total cost of \$1,200. Seconded by Mr. Robb. All in favor.
