CALL TO ORDER

The BUSINESS meeting of the District Township Board of Supervisors was held on May 15, 2025, at the Township Municipal Building, 202 Weil Road, Boyertown, PA at 7:00 p.m. In attendance were Chairman Ed Overberger, Supervisors Ron Leibowitz and Leonard Robb, Engineer John Weber, Solicitor Orlando, Secretary Jen Sauerwald, and Seisholtzville Fire Company Chief Jennifer Sacks. Treasurer Trish Hatfield, Emergency Management Coordinator Tim Adam, Mike Mutter of Eastern Berks Fire Department and Bally Ambulance Chief Mike Groff were absent. Mr. Overberger called the meeting to order at 7:02 pm

SOLICITOR – Eugene Orlando

- Right-To-Know Policy and Procedures Mr. Orlando is awaiting responses in order to proceed. The item will be addressed at next month's meeting.
- Seisholtzville Fire Company Fire Tax Agreement No action was taken
- Met-Ed Right of Way agreement Mr. Olando recommended obtaining a scaled drawing from Met-Ed with reference to township property boundary lines showing where this pole line is so that it can be clearly differentiated from the rest of the property.

ZONING OFFICER/ENGINEER – John Weber

- 2025 Crack Sealing Project Mr. Weber sent out four (4) requests for proposals and only received one
 (1) response from AMS, Asphalt Maintenance Solution, LLC. Mr. Weber recommended the project be
 awarded to AMS. A motion was made by Mr. Overbergy, seconded by Mr. Leibowitz to award AMS the
 2025 Crack Sealing Project at \$26.85 a gallon up to a maximum of 875 gallons. All in Favor.
- Lutz Road Culvert project Lutz Road was opened today. The patch from the garbage-truck damage still needs to be completed but the weather has caused the delay. The cost of the extra patch is approximately \$1,500 but the project had cost savings in other areas so it should be a wash.
- Complaints
 - 150 Bitting Road Mr. Weber reported that LTL sent a letter to the homeowner and spoke with her regarding the complaint. A representative from LTL also spoke with the Complainer to acquire more information. A representative from LTL also observed the property and no barking was heard. Due to lack of corroborating evidence, the Board instructed Mr. Weber to send the Complainer a letter stating that without any additional evidence the Township will not be able to pursue his complaint further.

ROADMASTER REPORT – Ed Overberger

- New Truck update No update at this time
- Chew Road Bridge update Meeting with Department of Environmental Protection. Due to findings of aquatic life use of fish, the construction window is limited to April 1, 2026 through August 31, 2026.
- Longswamp Township Mr. Overberger met with the Chairman of the Board and Roadmaster from Longswamp Township. District Township will create an Inter-Municipal Agreement that outlines the shared road plowing.
- Park issues
 - o People have been parking in the newly spread dirt.
 - A kid on a dirt bike has been riding in the parking lot and jumping the dirt pile.
 - The trash cans will be moved half-way down the driveway.
 - Dog waste bags are being left in the small trash can

- Bally Ambulance –124 calls for month of April 7 in District Twp.
- Eastern Berks Fire Department 49 calls for month of April None reported in District Twp.
- Seisholtzville FD Jen Sacks 25 calls for month of April 6 in District Twp
- Chief Sacks explained the labeling on the Monthly call report and responded to the following questions:

- There has never been a letter sent out stating that Seisholtzville FD will not respond to calls during the day.
- Brush Fire on Huffs Church Road Seisholtzville unable to respond
- Qualified Engine drivers = 5
- Firefighters that can enter a burning building = 14 Approximately 3 are available during weekday working hours.
- What level of service can Seisholtzville FD provide? At this point in time the FD does not have any firefighters that work close enough to the station to respond during weekday working hours. Weekday responses are hit or miss and usually only 1 or 2 firefighters present.
- The Board is concerned with the amount of time that lapses when Seisholtzville FD cannot respond and another FD is called. In addition, the uncertain reliability of weekday workhour responses has caused the board to consider withdrawing funding. Tabled until next month's meeting to allow for more consideration.
